The voluntary disclosure program (VDP) is a long term strategy intended to promote voluntary compliance by creating a window of opportunity for Taxpayers who have committed tax irregularities to voluntarily come forward and make full and honest disclosure of such tax transgressions.

The stakeholder engagement sessions will include pre - filing season tax clinics where Taxpayers will be educated and guided on completing accurate income tax returns. Taxpayers will also be guided on the processes for making payments of taxes due.
